





Okay. But other than this incident, Brad's done a lot of good as D11 Chair over the last two years, right?

Giving financial support to Democrats is certainly the most egregious thing Brad did in these last two years. But there are several other ways he demonstrated himself to be a poor leader in his role as D11 Chair, including:

- As a member of the GA GOP Executive Committee, Brad Carver failed to act to hold John Padgett accountable for not following the budget given to him. This allowed Padgett to bring the state GOP within months of insolvency.
- · As District 11 Chair, Brad Carver failed to ensure the District 11 GOP had a functional web site of any kind before the last few months right before the district convention.
- · As a member of the GA GOP state committee, Brad Carver led the effort to ensure a disproportional allocation Georgia's Republican delegates after the presidential primary. No candidate earning less than 21% of the popular vote was awarded any GA delegates to the Republican National Convention, a scheme the Establishment intended to help Jeb Bush, but which ultimately ended up backfiring and helping Donald Trump.
- As District 11 Chair, Brad Carver argued in favor of the National Popular Vote to replace the electoral college in an extended resolution discussion with the District 11 Committee. Had his proposal succeeded, Hillary Clinton would be President today.

I want to learn more about these kinds of examples of corruption in Republican politics in Georgia. I want to learn so I can understand how I can best help.
