STATEMENT OF FACTS (To be completed on attached complaint submission form or included as separate addendum to the complaint)

The present complaint is submitted against AFG Group, Inc. d/b/a Stacey Abrams for Governor ("SAFG") - the principal candidate committee of Democrat gubernatorial nominee Ms. Stacey Yvonne Abrams - in light of actions and conduct undertaken by the committee that appears to be in violation of the Georgia Government Transparency and Campaign Finance Act (the "Act"). Based upon the facts highlighted herein, as well as reasonable belief formed from media coverage of SAFG's activities in the wake of Governor-Elect Brian Kemp's victory on Tuesday November 6, 2018, there is a substantial basis to believe that SAFG has violated multiple tenets of Georgia campaign finance law that fall within the investigative and enforcement jurisdiction of the Georgia Government Transparency and Campaign Finance Commission (the "GGTCFC" or the "Commission").

In light of the facts set forth herein, we hereby request that the GGTCFC open an immediate investigation into the improper and unlawful conduct of SAFG and pursue all viable remedies available by law to bring an end to these blatant violations of Georgia's campaign finance laws.

Violation: Improper Disposition, Expenditure and Custodial Protection of Campaign Funds in Contravention of Sections 21-5-33 and 21-5-43 of the Act

On or about November 8, 2018 - just two days after losing the General Election race for Georgia's Governor to Governor Elect Brian Kemp - SAFG began disseminating a variety of campaign materials and seeking to purchase media advertising focused on matters related to a supposed 2018 general runoff election for Governor of Georgia. These materials and advertisements vary in tone and context, but singularly focus on the promotion and support of Stacey Abrams' candidacy for elective office in an election that does not exist and will not take place. For the sake of Commission review, we have compiled a handful of these materials as attachments to this complaint, including:

- A screen capture of a Twitter post by Ms. Lauren Groh-Wingo Campaign Manager for SAFG publicly alerting her several thousand followers and supporters of Ms. Abrams' campaign to the fact that SAFG was disseminating the aforementioned mailer related and purchasing the aforementioned radio ad buy for \$250,000 (see Attachment A);
- Examples of purchasing documentation for an attempted radio advertising buy across multiple outlets in Georgia promoting support for Ms. Abrams' candidacy in a non-existent 2018 gubernatorial general run-off election (see Attachment B);¹
- A November 13, 2018 advertisement promoting support for Stacey Abrams' candidacy in a non-existent 2018 gubernatorial general runoff election, which is paid for by the Democratic Party of Georgia and approved by Stacey Abrams. This might also amount to an excessive in-kind contribution by the Democratic Party of Georgia to SAFG. (see https://politics.myajc.com/blog/politics/new-abrams-count-every-vote/RqXsCoRI9Mlixj4Ld70hNJ/);
- A television clip from WSB mentioning that SAFG attempted to place an ad buy with WSB, which was subsequently rejected by WSB but accepted by other stations. (*see* http://mms.tveyes.com/transcript.asp?StationID=770&DateTime=11/11/2018%207:36:27 %20AM&playclip=true&pbc=search%3a%2b(abrams+ad)).

Additional examples of such 2018 general election run-off campaign activity by SAFG can be found in the public domain (in the multi-media context) and across the state (in the hard copy context).

Given the singular focus of the above materials and communications on supporting the candidacy of Ms. Abrams in a fictional 2018 gubernatorial general runoff election, there is ample

reason to believe that one or more violations of the Act have occurred. Although there is no transparency as to how SAFG is funding the above communications and related staff actions designed to promote Ms. Abrams' "candidacy" in a non-existent 2018 general runoff election for Georgia Governor, reasonable information and belief point to the fact that such expenses are being paid from one of two monetary sources - contributions taken in by SAFG for the 2018 general election or contributions taken in by SAFG in anticipation of a potential 2018 general run-off election. Spending of funds from either of these sources for the activities described in this complaint constitutes a violation of one or more provisions of the Act and should be immediately investigated by the Commission and punished to the full extent of the law.

If SAFG is utilizing 2018 general election contributions in its possession to defray costs associated with campaigning for a non-existent future election, such activity violates Sections 21-5-33 and 21-5-43 of the Act. As set forth in Section 21-5-33(a), contribution funds to a campaign committee can only be utilized to defray "ordinary and necessary expenses" incurred in connection with a candidate's campaign for elective office or such public officer's fulfillment or retention of such office. Concurrently, in Section 21-5-43(c), the Act specifies that contributions remaining unexpended after the date of an election may be expended for a future election in the same election cycle (to the extent one exists), or may be used as provided in 21-5-33 when no further elections exist in the election cycle or when the candidate of the campaign committee is not on the ballot of a further election in the election cycles.

Given the non-existence of a 2018 general run-off election for Georgia governor, it violates both the spirit and letter of the Act for SAFG to use 2018 general election funds for the advertising, material and staff costs identified above. Spending on campaign activities for a fictional future election that has no mathematical possibility of occurring is on its face neither ordinary nor necessary campaign spending by SAFG. In turn, it is a prospective violation of Section 21-5-33 (a) of the Act. Similarly, even if SAFG has excess funds from the 2018 general election to spend on advertising, material and staff costs in the wake of the November 6th election, it is not permissible to spend such costs on activities not delineated in Section 21-5-33(b) of the Act. Paying for radio advertising, media buys and staff costs associated with a 2018 general run-off election that will not take place using excess general election funds does not fit into any of the permissible categories under Section 21-5-33(b) (e.g., charitable contributions, committee transfers, refunds, debt repayment for past election, or for use in actual future campaigns). As such, SAFG is prospectively violating both Sections 21-5-33(b) and 21-5-43(c) of the Act by funding activities for a non-existent general run-off election from excess general election funds.


If SAFG is utilizing 2018 general run-off election contributions (as opposed to 2018 general election contributions) in its possession to defray costs associated with the described campaign activities, such activity expressly violates Section 21-5-43 of the Act. The language of Section

21-5-43(d) prohibits a candidate's campaign committee that accepts contributions for a potential future election and separately accounts for such funds by way of an "Option to Choose Separate Accounting" (COOSA) from spending such contributions on the future election if it does NOT occur or if the candidate does not qualify for such future election. In such a setting, a candidate is required to return all accepted and accounted for funds to his or her applicable contributors pro rata without interest.

Given the non-existence of a 2018 general run-off election for Georgia Governor, it violates both the spirit and letter of the Act for SAFG to expend any 2018 general run-off funds it has accepted during the 2018 election cycle. Spending of these embargoed funds for any purpose - whether on the activities described herein or on activities related to litigation and SAFG wind down - runs directly afoul of SAFG's contribution custodial duties under Georgia campaign finance law and ostensibly prevents the campaign committee from fulfilling its legal obligation to donors to refund such contributions because of Ms. Abrams recent loss. In light of these facts, the Commission should take immediate action to investigate SAFG's potential spending of 2018 general run-off election contribution funds in violation of the Act and take all appropriate action to halt such behavior and assess appropriate penalties under Georgia law.
